

# The Grand Scheme of Waqf Nau (1987)



On April 3, 1987, Hazrat Mirza Tahir Ahmad (rh), the fourth Khalifa of the Promised Messiah (as), launched the splendid initiative "Waqf Nau" as scheme which was started in result of a powerful and divine inspiration. He envisioned that with the dawn of the second century of Ahmadiyyat, numerous venues will be opened for the domination of Islam and Ahmadiyyat for which a large number of upright devotees will be needed to cause a revolution in the field of Tabligh.

Instantly, the Jama'at demonstrated their devotion and dedicated their children in the way of the scheme of Waqf Nau. This scheme grew ever rapidly and Allah continued to shower His blessings on the blossoming

of a new generation, Waqf Nau. Today, these children are the assets of Jama`at who are destined to play an unprecedented role in spreading the name and faith of the Holy Prophet (sa) "to each corner of the earth." Insha`Allah

### **Enrolment and Registration**

For enrolment into the scheme, parents should follow the guidelines stated below. For a successful process, a hardcopy record of all documents in the process of enrolment and registration *must* be kept.

#### Read the Book: Tahrik Waqf Nau

All parents who desire to dedicate their children for the cause of their faith, must read the book Tahrik Waqf Nau. It is a compilation of five Friday Sermons which were delivered at the launch of the divine scheme of Waqf Nau.

#### **Step 1:** Letter Seeking Approval for Waqf

A letter should be written by parents to Hazrat Khalifatul-Masih (may Allah be his Helper!) requesting him for his approval to dedicate their unborn child into the blessed scheme of Waqf Nau. It is important to note that the letter of request must be written before the birth of child and as early as possible.

#### **Step 2**: Approval and Enrolment Process

If Huzoor (may Allah be his Helper!) grants approval to the parents' request, a letter of approval will be received by the parents from UK. It is critical to save a copy of this letter of approval as it will **not** be re-issued. Along with the approval letter, an enrolment form will also be received by the parents which need to filled out after birth of child.

### **Step 3:** Registering a Waqf Nau After Birth

Form which was received with the approval letter, must be filled out, and sent back to UK as early as possible. Please keep a copy for your reference. After the birth of the child, a file should be prepared for the child.

### **Step 4: Waqf Nau Reference Number**

Upon verification of registration, parents will receive a letter from International Department of Waqf Nau headquartered in UK consisting a "Waqf Nau Reference Number." This "Reference Number" is the child's unique identity which is saved in the worldwide database. Please do not misplace this important document as it exhibits child's registration as a Waqf Nau. With the receipt of the "Reference Letter", the child is now officially enrolled into the blessed scheme of Waqf Nau.



<u>Step 5 (last)</u>: Parents must send copies of all documents from Steps 1-4 to the National Department of Waqf Nau Canada so they can be saved in the child's records. Originals should be kept by parents.

### In Case of Migration of a Waqf Nau

If a Waqf Nau child was born outside Canada and now has moved to Canada, parents must:

- 1. Enrol their Waqf Nau child into the Canadian Waqf Nau list by providing child's Reference Number Letter to the National Department of Waqf Nau Canada.
- 2. Inform International Department of Waqf Nau, UK, about the change of address by filling out the "Change of Address" form [link form].
